ARTICULATION AGREEMENT

College of Southern Maryland, Associate of Applied Science Degree in Human Services

Continuing and Career Education at Assumption College, Bachelor of Arts in Human Services and Rehabilitation Studies

College of Southern Maryland (here after referred to as CSM), a community college in La Plata, Maryland, and *Continuing and Career Education at Assumption College in Worcester Massachusetts (here after referred to as CCE at Assumption College,* regionally accredited by The New England Association of Schools and Colleges, *(NEASC)*, agree to offer an articulated program leading to the award of an Associate of Applied Science in *Human Services* and a Bachelor of Arts in *Human Services and Rehabilitation Studies*. They further agree that students from CSM, through this articulation agreement, will be allowed to transfer credits earned for the associate degree at CSM to CCE at Assumption College, leading to the award of the baccalaureate degree at *Assumption College*.

Purpose of the Agreement

This agreement is entered into to serve the instructional needs of CSM students and graduates. Its general purpose is to make clear the terms of the transfer.

By doing so, this articulation agreement will facilitate an efficient transition from CSM's *Human Services* to the *Bachelors of Arts in Human Services and Rehabilitation Studies* at *Assumption College*. CSM graduates will understand how *CCE @ Assumption* transfers the credits they earn at CSM, as well as the changes in requirements that may permit more flexible scheduling once the student has been admitted to and enrolled at *Assumption College*. The agreement provides a systematic plan for students to continue their higher education beyond the A.A.S. degree from CSM.

The agreement, also, is a publication of a clear set of understandings and expectations for both institutions and programs. Making expectations clear to students and between institutions not only contributes to the first goal, but also allows the institutions to work collaboratively to meet the needs of CSM graduates. Like any policy agreement, this articulation agreement will need to be updated, revised and refined as the instructional programs are revised.

Finally the agreement encourages CSM graduates to continue their educational pathway for both personal and professional development, as well as career advancement. It facilitates students' successful achievement of credentials in their field.

Guiding Principles

The following general principles guide the operation of this Agreement:

1. The program is designed for graduates of the A.A.S. degree in *Human Services* at CSM. A maximum of 75 credit hours from CSM will be allowed toward fulfillment of the 120 credit hours required for baccalaureate completion.
2. All courses meeting general education requirements at CSM will transfer to *CCE at Assumption College* as general education.
3. Students must maintain a 2.0 cumulative grade point average in order to transfer.

4. The maximum number of credits that will be accepted by *CCE at Assumption College* toward degree requirements from non-direct classroom instruction (including CLEP, AP, and other nationally recognized standardized examination scores) is 30. The College-level Examination Program (CLEP), sponsored by the College Board allows students to earn college credit by demonstrating their mastery of college-level material. Students who achieve a passing score on a CLEP examination may earn introductory-level college credit. Tech Prep credits *will* transfer where appropriate. Credit awarded for experiential learning (“life experience”) is recognized by Assumption College, however is *not* transferable to, *Assumption College*. Students would need to resubmit a portfolio to challenge a class with experiential learning.
5. Once the A.A.S. is completed and the student has been admitted to *CCE @ Assumption College*, the student may commence the *Bachelors of Arts in Human Services and Rehab Studies program after completion of full application and official transcripts have been evaluated for transfer*.
6. CSM students who have completed the A.A.S. Degree in Human Services will be given every consideration for financial assistance and will be eligible to compete for academic scholarships at *CCE @ Assumption College*.
7. This agreement becomes effective on the date set forth on the first page of this document. CSM and *Assumption College* agree to publicize this program. They further agree to monitor the performance of this agreement and to revise it as necessary. The agreement may be terminated by either party for due cause and after adequate notice to the other. Termination of the agreement *will not* affect any students currently enrolled at CSM in the *Human Services program* at the time of termination, and they *shall be able to* transfer credits pursuant to this agreement.
8. *CCE @ Assumption College* will establish a mechanism to provide information on the academic progress of the CSM student enrolled as a result of this agreement.
9. Grade requirements-Students who graduate from the Human Services Associate in Science degree with cumulative grade point average (GPA) of 2.5 or higher will be guaranteed admission into the HSRS major under the terms of this agreement.

Program Articulation A.A.S. in Human Services and B.A. in Human Services and Rehabilitation Studies
