



## Dream Act Eligibility Worksheet

As an open-admission institution, The College of Southern Maryland grants admission to all students regardless of citizenship. Maryland Senate Bill 167 enacted in the 2011 Session of the Maryland General Assembly, also known as the Maryland Dream Act, allows some non-U.S. citizens to be exempt from paying the out-of-state tuition rate.

**In order for a student to qualify for an exemption from paying out-of-state tuition, you must be able to answer “YES” or “N/A” to all questions below and provide proof. This work sheet is intended only as a guide to assist you in determining eligibility. You must submit an “Affidavit for Undocumented Immigrant Student Tuition Rate” and proof of requirements to the admissions office for consideration.**

**Students must be able to provide the following items to the Admissions Department for review:**

- ✓ Completed Affidavit
  - \*available at [www.csmd.edu/admissions](http://www.csmd.edu/admissions)
  
- ✓ Maryland High School Transcript
  - \*must denote that you graduated
  
- ✓ Maryland High School Diploma
  
- ✓ Maryland Income Tax Return
  - \*Must provide returns from each year student was in high school, each year between high school and college (if any), each year enrolled in college (if any)
  - \*Must either be from the student or the parent(s)/legal guardians
  - \* Federal returns not accepted
  
- ✓ All Males Ages 18 and older must submit proof of registration with Selective Service
