All funding will be awarded from 2023-24 academic year, if available. The more funds borrowed for fall and spring, the less loan funds you will have available for summer.

## Satisfactory Academic Progress may not be calculated for returning students until after the 100% refund period for the summer sessions beginning May 14<sup>th</sup>. Loans for students not meeting academic progress at that time will be canceled.

I must be actively enrolled in and attending at least 6 credits required for my program to receive my loan funds. If it is determined I am below 6 credits at the time of my loan disbursement, my loan funds will be returned to the Department of Education.

I must have been a credit student at the College of Southern Maryland in Spring of 2024, registered in credit classes Fall of 2024, or send written confirmation I am not a visiting student to be considered eligible for summer loans.

If faculty documentation shows I was not actively enrolled for 6 credits (including unofficial withdrawals as reported at the end of the semester) at the time of my loan disbursement, I will be responsible to immediately repay any ineligible loan proceeds disbursed to me.

If I am enrolled in a late start class, the loan disbursement and any refund amount due may be delayed.

I will/have completed the required Entrance Counseling and Master Promissory Note and authorize the College of Southern Maryland to request loan funds on my behalf as indicated above. <u>https://studentaid.gov/h/manage-loans</u>

I understand that the calculation to determine my eligibility was based on my enrollment status at the time I submitted my application. The financial assistance office may adjust my loan if I receive additional awards or if I make any adjustments to my enrollment (including dropping, adding, withdrawing, and non-attendance). Satisfactory academic progress will be calculated at the end of the spring term. If I am unsatisfactory, I will no longer be eligible for a loan. The amount credited to my account will be the principal amount listed above minus an origination fee.
