### Calvert County Can Help Communities and Support the Local Economy by Directing ARPA Funds to Nonprofits

Nonprofits and government are natural partners, serving the same constituents in the same communities. Partnerships between the sectors allow for leveraging of resources, relationships, and strengths to serve those communities even better. Congress specified that funding for nonprofits is an eligible use of Rescue Plan money. Calvert’s nonprofits have close relationships and high levels of trust with those they serve. They are perfectly positioned to maximize public benefits with their deep knowledge of community needs, reach, and existing relationships, particularly in low-income and underserved or hard-to-reach populations.<sup>1</sup>

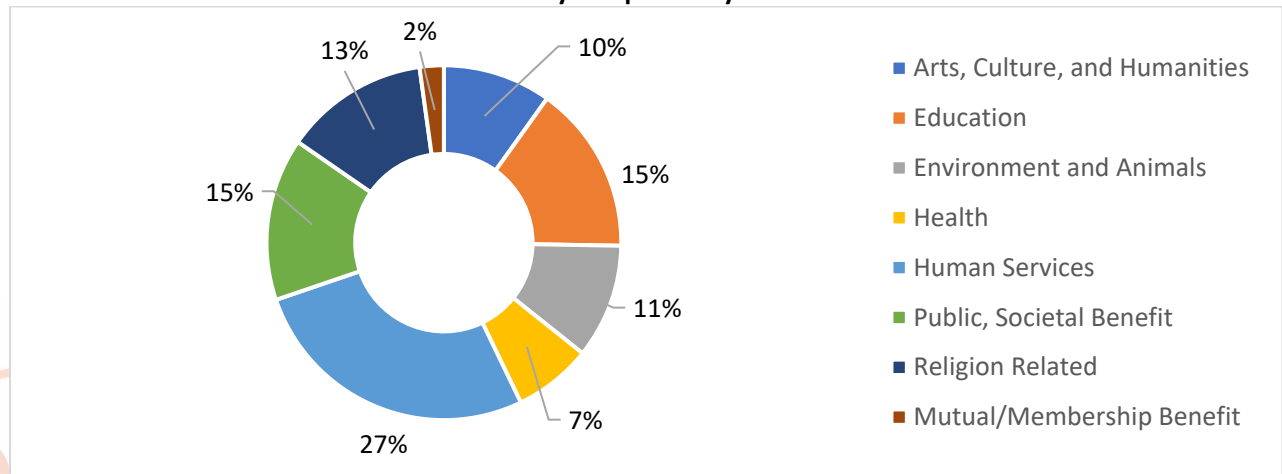
#### American Rescue Plan in Calvert County

Thanks to the efforts of our federal advocates, the American Rescue Plan Act of 2021 (H.R. 1319) Coronavirus Local Fiscal Recovery Fund has allocated an estimated \$17,971,987 to Calvert County Government.<sup>2</sup> These funds must be expended by December 31, 2024 and may be used to respond to, prepare for and replace revenues lost as a result of COVID-19. By allocating a substantial portion of its American Rescue Plan Act funding to nonprofit grants, Calvert County Government will maximize its impact and stimulate its local economy in this time of exceptional need.

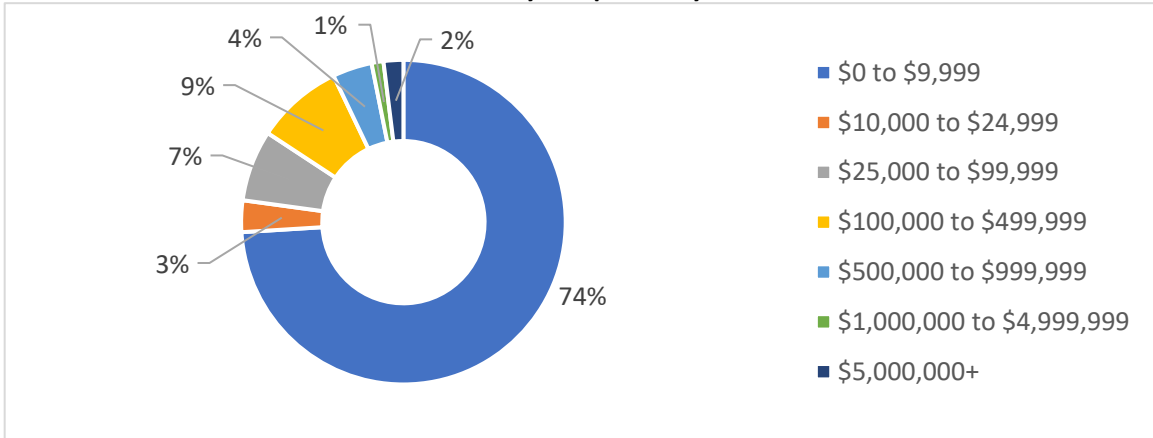

- Child Development: Childcare programs are easing the burden on working parents while developing tomorrow’s workforce
- Public Health: Health initiatives result in healthier happier families and more productive employees
- Arts & Culture: Arts and cultural nonprofits are important for tourism and increase Maryland’s reputation as a great place to live and work
- Most of Maryland’s nonprofits are small. 89% have annual revenue under \$500,000.<sup>7</sup>
